Colorado Brain Injury Collaborative

The Colorado Brain Injury Collaborative is dedicated to improving the lives of the approximate 500,000 individuals living with brain injury in Colorado through public policy and education.

Recent successes include HB 1398 Implement Respite Care Task Force. The bill requires the Department of Human Services to select a contractor to implement the recommendations of the Respite Care Task Force.

HB 1321 Medicaid Buy-in Certain Medicaid Waivers directs the Department of Health Care Policy and Financing (HCPF) to seek federal authorization to implement a Medicaid buy-in program for adults who are eligible to receive home-and community-based services under the Brain Injury (BI) waiver.

Pathways Program

The Pathways Program makes life easier for a survivor and their family by providing them with the confidence and peace of mind that BIAC will be checking in with them at regular intervals to provide support. Case-management is also readily available.

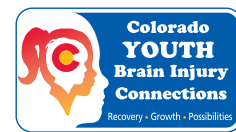

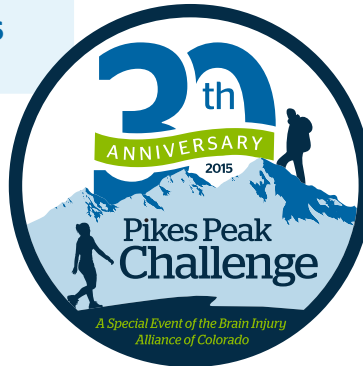
Conferences and Workshops
